The current enrollment stands at over 50 students ranging from grades K-12. Tuition includes education for one year, field trips, supplies and hot lunches daily. Although the annual costs for each student stands at approximately \$7,000 per year, tuition is based on each student's parent's income and is often around \$55 per month. The remaining funds are provided by donations from caring supporters.**
